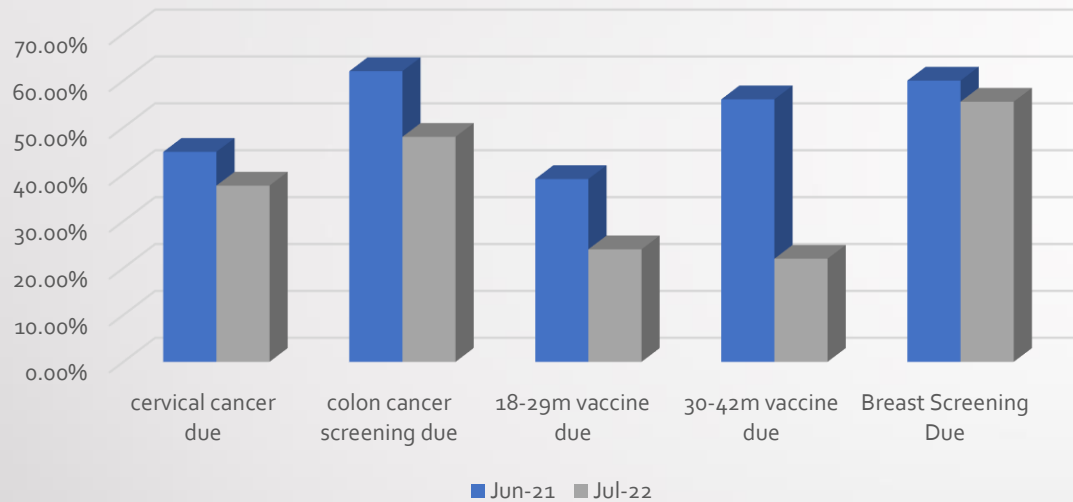

# Cervical Cancer Mini QIP

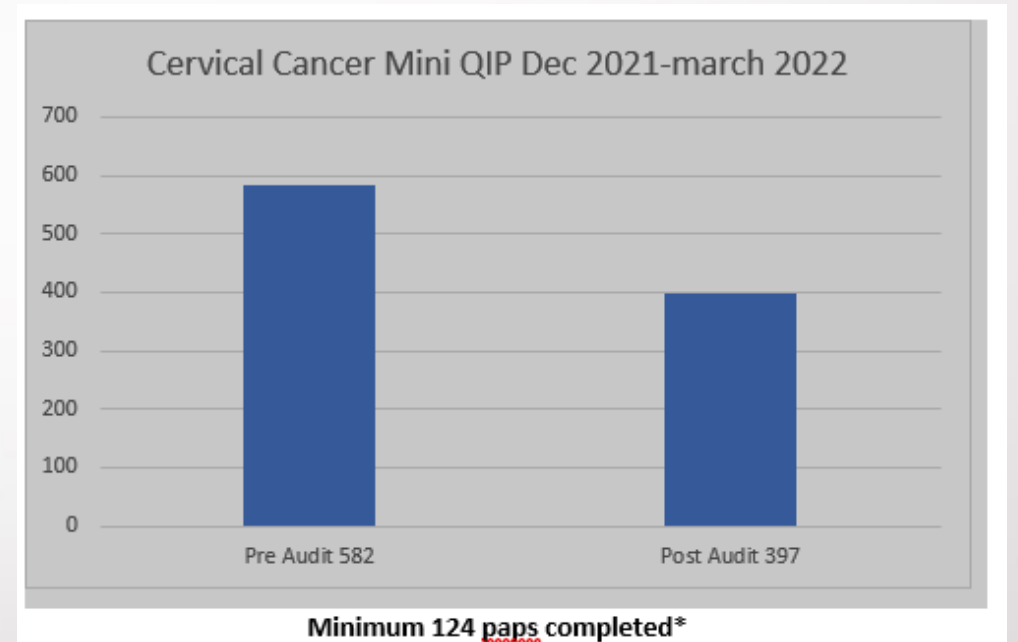
125 overdue paps completed in 3-month time period. This is a rolling number so more added as they become due.

## Water Street Move

- Ministry of Health approved “site selection” tab of the application
- Now working closely with architect and consultant to complete “Cost Estimate” tab (the final section)
- We are aiming to submit this tab by mid September

## Strategic Plan

- WRNPLC committed to support carbon neutrality in our latest strategic plan. We are asking the board to reach out to the Alliance for Healthier Communities (AHC) to request that this responsibility be incorporated into the words and actions of our provincial association; that our role in environmental stewardship be added to the AHC strategic plan and Model of Health and Well Being.
